General Manager's Report

Has been exciting getting back into the swing of things. Since our last meeting, product has started to arrive. Still waiting on lots, but over the next week we should have 95% of what we plan to sell in the shop this year. There have been some "COVID delays" in shipping, as well as shortages as golf continues to absolutely explode.

Standard start-up type things have happened. Garbage and recycling bins were delivered, furnace oil delivered and turned on, computers were re-installed and internet and phone lines reconnected.

Staff Hiring

Kylie has arrived in Yellowknife and is isolating. All of her Protect NWT paperwork was completed and all she will need to do now is keep up with the weekly check-in emails they send. We've also hired all our full-time and part time staff for the proshop. All driving range attendants have been hired, and we await one final response for our three grounds and maintenance staff. Will be a nice mix of youth and older staff in the proshop this year.

Canada Summer Jobs Application (Service Canada)

Speaking of staff, we have made it thru the final round of the application process with Canada Summer Jobs for a grounds and maintenance position as well as a proshop staff. Hoping to hear back soon, so we can update the budget.

Northern Golf Course Member Rate

A few years ago, a small course in Alberta setup a "dollar-a-hole" rate with NWT and northern Alberta courses. Was a cool program and benefitted our members who wanted to travel down south. When COVID struck, we bowed out of that program as the border was closed. This year we thought we would try to have an NWT version of the program. I reached out to Hay River, Fort Smith, Fort Simpson and Inuvik asking what they would charge members from other courses. We've had good discussions and will have a poster done up to have other courses put up at their establishments. We've made note that clubs need to provide their members with something indicating their membership.

Bag Tags

After many members complained about no bag tags last year, and the Tee-On cards not being able to do what we initially thought they could, decided to order bag tags this year. Was given a beautiful photo taken by a friend of mine this winter that was used for the back (will show at the meeting if anyone wants to see).

Memberships

They continue to roll in. We are now sitting at 67 memberships for the 2021 season. The online platform with Tee-On makes this very easy for both our members and us as in the proshop.

Course Slope/Rating

Once again, this year, Golf Canada (thru Alberta Golf) will not be slope/rating courses. We had intended to get that done last year. We have ordered the same scorecards that have been used the past few years in order to tie us over until next season when we can hopefully get slope/rated.

Drive/Chip/Putt Jr Tournament

Jenni/Winter came up with a great initiative to try and drive Jr golf at our club. It has been a long time since we've had a strong junior program. Would be great if this helped that. We met and discussed how to make it happen. We have a sponsor (Northern Integration) and the City of Yellowknife has agreed to have a small blurb about the tournament in the City of Yellowknife email they send those who register for JR lessons. Booked for August 7th.

City of Yellowknife Jr Lessons

We have partnered again with the City of Yellowknife for this. Kylie will once again head this program. Looking to build on the program, and help it potentially grow the Drive/Chip/Putt tournament.

Solar Power Committee Report to the Board of Directors

The YKGC typically consumes electricity in the months from April to September. The electricity consumption is mainly attributed to charging the fleet of golf carts which are powered by rechargeable batteries. The Clubhouse and Pro Shop add to the consumption of electricity.

As Yellowknife experiences some of the highest power rates in Canada, it was determined that a committee would be struck to investigate the opportunity to invest in a solar panel array to offset the power consumption at the golf club. Jeff Oldfield, Hughie Graham and Cole Marshall agreed to form the committee to investigate solar power at the golf club.

Several companies were contacted to gain high level information of installation and budgetary costs. NWT Solar conducted a site visit and was provided 2021 power bills to put together a comprehensive proposal to meet our electricity needs. That report is attached. Here is what NWT Solar found.

□ To offset the Golf Club's 2021 consumption, a **57-kW solar installation** is proposed. Solar panels would be set up in three areas, the Clubhouse Roof, the Pro Shop roof, and the Cart Garage near the 18th green.

□ Initial capital cost would be **\$146,696.61** with a **25-year life** on the solar panels.

□ With the electricity generated and put back into the Yellowknife power grid, **an 8-year payback** is calculated.

□ This provides an **11% return on investment** though modelled on a .30/kWh. This does not speculate on the cost of power increasing which would provide a greater return on investment.

□ Though large in nature, this project would **offset electricity costs by 77%** and there would be still some demand charge. This could provide for additional savings, however, as we may be able to have the peak demand reset thereby lowering the multiplier of demand.

□ NWT Solar's proposal does fall within the budget cost of \$2.00 - \$3.00 per watt that we found was an acceptable cost from other solar suppliers. That cost is averaged at **\$2.30 per watt.**

At the March Board of Directors meeting, there was a question for project breakdown and recommendation from the Solar Power Committee. The breakdown is as follows. Clubhouse Installation 35,275 W Solar System **Clubhouse Installation** 35,275 W Solar System \$87,753.62 + GST **System Annual Generation** At .29¢ per kWh \$8,234.61 **Cost per Installed watt**

\$2.20

Proshop Installation

13,600 W Solar System \$32,775.20 + GST System Annual Generation At .29¢ per kWh \$3,254.24 Cost per Installed watt \$2.13

Cart Shed Installation

6,800 W Solar System \$19,192.93 + GST System Annual Generation At .29¢ per kWh \$8,234.61 Cost per Installed watt \$2.50

Trailer Installation

35,275 W Solar System \$6,974.86 + GST System Annual Generation At .29¢ per kWh \$825.83 Cost per Installed watt \$3.63

The Solar Power committee's recommendation is to proceed with all installations as to maximize the offset power generation from the solar panel installation. Note there are 4 installations due to the 4 power meters that are in site at the golf club. Respectfully
